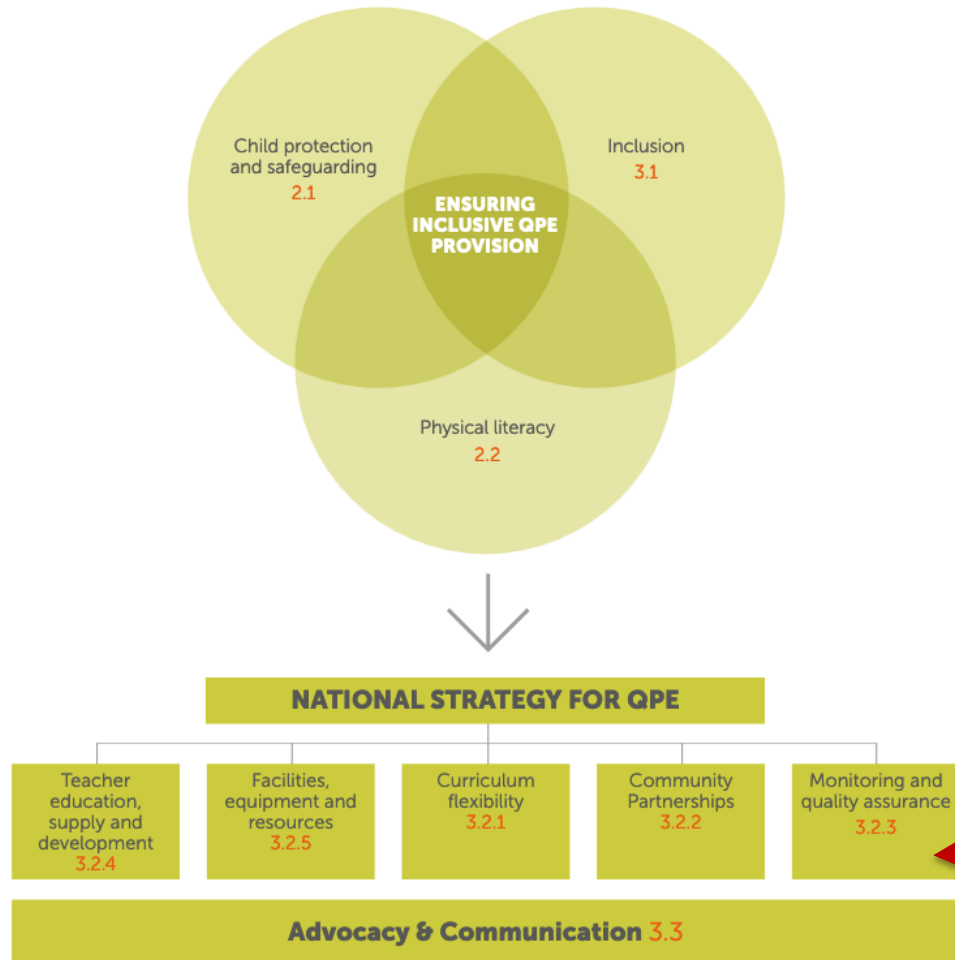

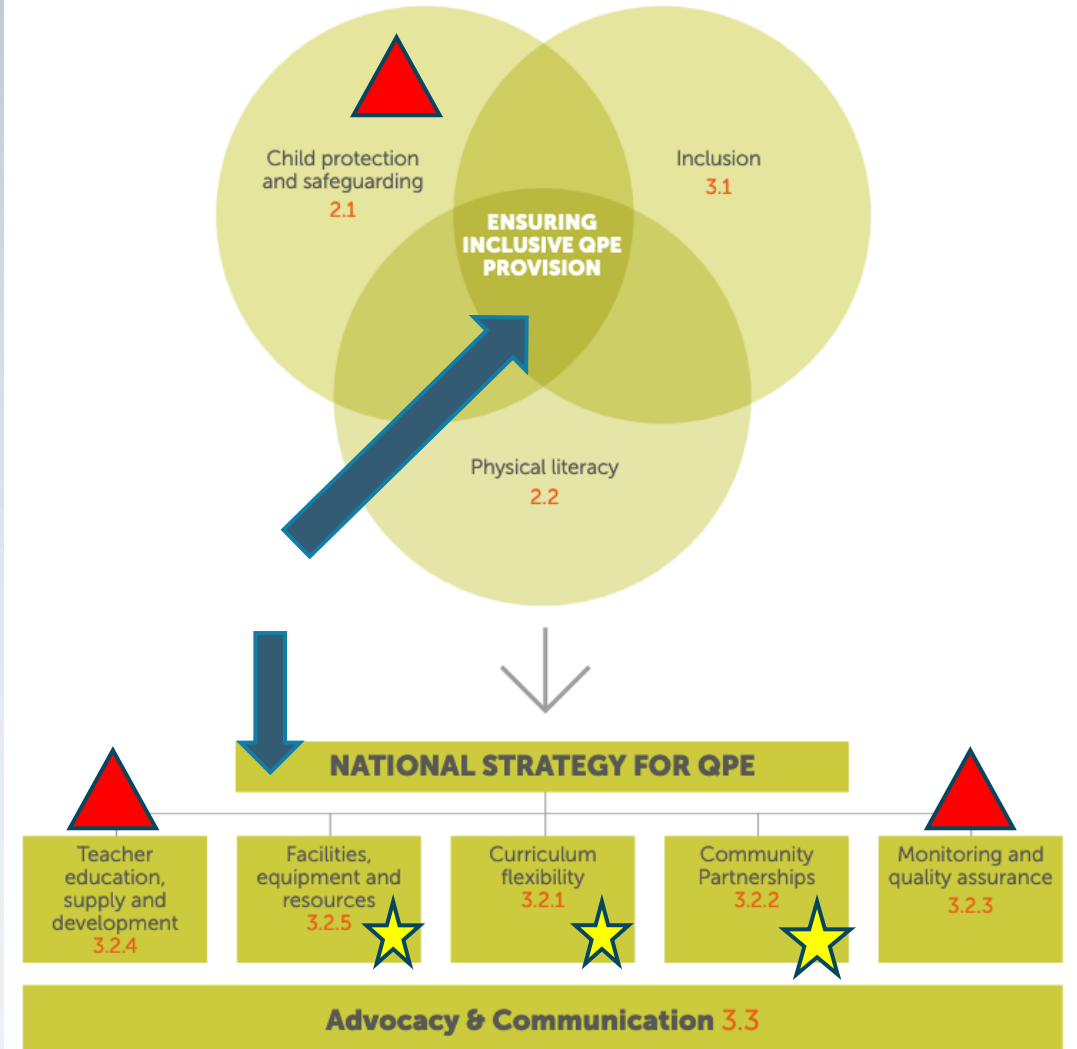
5. Discussion

Q1: What strategies do directors and educators in specialized institutions use to integrate sports and artistic practices into their curricula?

Q2: How do they perceive the impact of these practices on student outcomes?

- Opportunities PL : facilitates equipment and resources, curriculum flexibility, community partnerships (Hutzler et al, 2023)
- Supported by the government, monitoring and quality assurance
- Practices that validate ableism (Whithead, 2019; Pushkarenko et al., 2023)

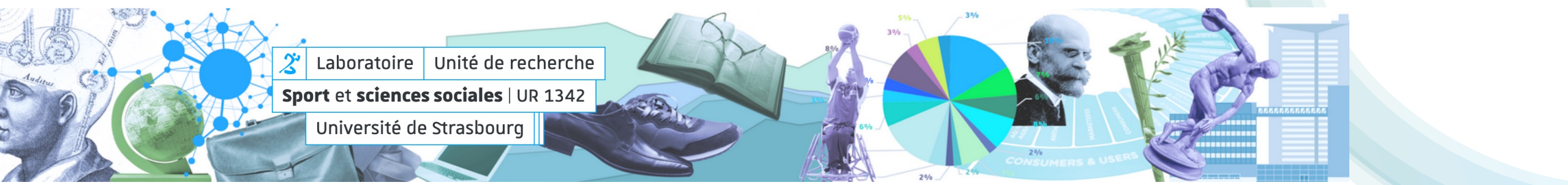
